Earning Criteria:
Applicants applying to become NCCAOM PDA Providers undergo a rigorous review and interview process. Requirements include:
 IF Maintenance of Active Certification status if an NCCAOM Diplomate
 IF Maintenance of a clear and unrestricted state acupuncture license, if applicable
 IF Verification of the resume/curriculum vitae for education and professional experience
 IF Website evaluation for professional representation and ethical advertising methods
 IF Adherence to the NCCAOM Code of Ethics, the NCCAOM Grounds for Professional Discipline, NCCAOM PDA Agreement, and the NCCAOM PDA Product and Service Disclaimer.

Courses approved by the NCCAOM PDA Department must meet the following requirements:
 IF Course content must meet standards for Continuing Education & Training
 IF Course content must apply to one of the NCCAOM Re-certification categories
 IF Instructors must meet qualifications in education, practical experience, licensure, and teaching experience via a professional resume
 IF Courses must be applicable to one of four course types
