I am pleased to announce that last month the NCCAOM launched our Facebook page which resulted in an immediate response from the AOM community by reaching 1,250 likes within 24 hours of this launch!

This response rate was welcoming and assured us that our decision to use social media as a new communication tool is truly desired.

Our motivation for exploring social media and its use for further communication to NCCAOM Diplomates, the public and other NCCAOM constituents was a steady, deliberate process, as we contemplated whether Facebook, LinkedIn or Twitter, for that matter, would be the next most appropriate form of social media communication for our certification organization.

Customer Service, a key function and core value of the NCCAOM, has its roots in the person-to-person conversations that linked our constituents to one another for over 30 years. Michael J. Garland, D. Sc. Rel., is Professor Emeritus of the Department of Public Health and Preventive Medicine, Oregon Health & Science University, and has served on the faculty since 1978. He received a doctorate in religious studies from the University of Strasbourg in France, where he focused on ethics. Garland has published widely on ethical issues in health policy. He was invited to join the NCCAOM Board of Commissioners in January 2005. He served as Treasurer to the Board from 2006 until February of 2011. Garland was Chair of the Finance Committee and provided his volunteer service as a member of the

Professional Ethics and Disciplinary Committee (PEDC), the Governance Documents Committee and the Board Development Committee. Michael Garland's wisdom and humor will continue to be missed.







Bryn Clark, L.Ac., Dipl.O.M. (NCCAOM)® began his career with the study of Japanese Shiatsu in 1989. His later studies included a number of Asian Bodywork modalities. He became a Diplomate of Oriental Medicine in 2004. Clark has held faculty positions in two ACAOM-accredited Chinese Herbology programs: the Academy for Five Element Acupuncture, in Hallandale, Florida, and Maryland University of Integrative Health (Formerly: Tai Sophia Institute), Laurel, Maryland. He helped found the Congress on the Future of

Traditional Medicines, which seeks to preserve Oriental medicine practitioners' access to their historical Materia Medica, amidst increasing FDA regulation. Clark was elected to the NCCAOM Board of Commissioners in 2002, and served as Treasurer in 2004, Vice Chair in 2005, Board Chair in 2006-2007, and Board Secretary from 2010 through 2012. Clark held positions on a number of standing committees of the Board and currently serves as Chair of the Research Committee and the Eligibility Committee. Clark remains in private practice at his clinic, New Harmony Center for Health and Wellness, in Beverly, Massachusets. Clark's passion for in-depth examination of AOM issues and thoughtful approach to decision making will also be missed.

We offer a heartfelt thank you to both gentlemen for your years of selfless service to the advancement of the AOM community through your dedication to the work of the NCCAOM.

### **Simplifying Recertification**

Diplomates who recertify every four years are considered to be in Active status. Diplomates in Active status demonstrate that they have completed competency maintenance for their certification or certifications by completing the recertification process every four years. Maintaining an Active status assures patients, employers, regulatory agencies, third party payers and other members of the public that these Diplomates continue to uphold meeting their certification requirements.

Active status entitles Diplomates to all of the benefits of certification.





Recertification is achieved through a program of Professional Development Activities – a process of continuing education and professional enhancements, for which a Diplomate acquires 60 PDA points during the four-year recertification cycle.
